Renville County has made available a fast, convenient, hassle-free way to pay for property taxes with the Direct Payment Plan.

With this convenient program, you can have your property tax payment automatically deducted from your checking or savings account at your financial institution on a semi-annual basis.

The Direct Payment Plan will help you:

- ✓ Save time writing and mailing checks.
- ✓ Save money in postage and bank fees.
- ✓ Eliminate the worry of late payments or lost checks associated with penalties.
- ✓ Be assured your tax payment is always made on time.

How does the Direct Payment Plan work?

You authorize payments to be made from your checking or savings account according to the following schedule:

May 15 th	. ½ of the annual tax payment
October 15 th (non-ag parcels)	. ½ of the annual tax payment
November 15 th (ag parcels)	. ½ of the annual tax payment

Proof of payment will appear on your bank statement. The authority you give Renville County to charge your account will remain in effect until **YOU** notify us in **writing** to terminate the authorization.

Take advantage of this service by completing the authorization for and returning it to us by the following dates:

April 15 th	April 15 th for First ½ taxes payable May 15 th	
September 15 th	for Second ½ taxes payable October/November 15 th
