# Motor Vehicle

- Renew registration for passenger vehicles, trailers, motorcycles and trucks (commercial and farm)
- Title transfers for new and used vehicles
- Temporary weight increase permits
- Registration and title transfers for out-of-state trucks (Prorate)
- Process applications for specialty plates
  - Critical Habitat
  - Collegiate
  - Veteran
  - “Black Out”
- Print crash reports

# Drivers License and I.D. Cards

- Renewals or duplicates of instruction permits, provisional, identification cards and standard driver's licenses (Class A, B, C and D)

- Real IDs and Enhanced driver's licenses

*Real ID deadline is May 7, 2025*

- Disability Certificates and Plates
- DOT health card (CDL medical certificates) updates for commercial drivers
- Driver's License Records Requests



# Department of Natural Resources (DNR)

- Transfer and registration renewal on snowmobiles, watercrafts, ATVs, off-road vehicles and off-road motorcycles
- Hunting Licenses
  - Deer
  - Pheasant
  - Waterfowl
  - Turkey

- Fishing Licenses
- Firearm and Safety Certificates
