#### Building for the Future: A Vision for Empowering Families and Strengthening Services

The Renville County Board of Commissioners appoints citizens, and local officials, to serve on a variety of advisory boards and committees. Renville County's advisory committees, boards, and commissions advise the County Board of Commissioners on issues that affect residents.



#### **Board of Adjustment and Appeals:**

Exclusive authority to hear, and decide, appeals and review any order.

requirement, decision, or determination made by the Zoning Administrator regarding administration of Land Use Ordinance.

**Extension Committee:** Determines needs of the County and recommends program implementation to fulfill the goals of the people of the County and of the Minnesota Agricultural Extension Service.

**HRA/EDA Board:** Provides programs and opportunities to expand and enhance economic development opportunities in Renville County and coordinates and administers two federal housing programs (Housing Choice Voucher (Section 8) and Public Housing).

Lake Allie ESSD Advisory Council: Study and make recommendations to County Board on amendments to Lake Allie Environmental Subordinate Service District Wastewater Collection System Ordinance.

**Parks and Trails Committee:** Study, report, and make recommendations to County Board on amendments to Park Ordinance and Parks and Trails Plan.

**Personnel Board of Appeals:** Hear appeals of applicants, employees, or appointing authority in certain circumstances and make findings of fact and report to the County Board.

**Planning Commission:** Study, report, and make recommendations to County Board on amendments to Land Use Ordinance and Comprehensive Plan.

#### Purpose

Advisory boards and committees bring the community perspective, provide advice, and/or make recommendations to the County Board on various issues and topics. Boards and committees do not establish county or department policy, determine budget or resource allocations, or direct the operations of a department.

#### **Prospective Candidates and Vacancies**

Residents and representatives are encouraged to apply and participate. All prospective candidates are required to submit an application, which can be found on the County website at <u>www.renvillecountymn.gov</u> – About Us – County Committee Application.

Appointments, and reappointments, are approved by the County Board. Committee members are eligible for per diems (currently \$55 or \$65 per meeting) and mileage reimbursement based on the current IRS rate.

# Bidding Farewell to Cindy Grosklags and Reflecting on 30+ Years of Service in Renville County Human Services



A fter more than three decades of service to Renville County, Cindy Grosklags has stepped into retirement. Her journey with Renville County Human Services started as a Social Services Supervisor and concluded in the role of Human Services Director. Her leadership and dedication have left a permanent mark on the County's Human Services landscape.

#### **Career Highlights: Advocating for the Underserved**

Reflecting on her career, one of the highlights was identifying Housing and Urban Development (HUD) funding as a key resource for improving housing for individuals with developmental disabilities. Working with a nonprofit provider, she assisted in securing grants to build two new homes in Bird Island and Olivia, plus two duplexes in Olivia; providing much-needed housing for those with disabilities. Cindy also worked with the former Administrator of Renville Health Services, prompting application for HUD funding that led to construction of an income-based senior apartment building in Renville. These efforts not only improved the quality of life for many but also demonstrated the power of teamwork and perseverance.

After PrimeWest Health's County-Based Purchasing Program was established, Cindy worked closely with Cindy Firme, Renville County's Public Health Nurse Supervisor, on the Public Health / Human Services PrimeWest Supervisory Committee to establish a Care Coordination Program for people over the age of 65, helping to address the unique needs of older residents.

### **Overcoming Challenges: Adapting to Change**

One of the greatest challenges during Cindy's career was navigating the constantly evolving service program requirements. As regulations became more prescriptive, it often limited the flexibility to provide individualized care, particularly in rural Minnesota where resources can be scarce. However, these challenges spurred growth and led to her advocacy for change. Cindy's advice to those facing similar hurdles is to become an active advocate for the people they serve, collaborate with regional and state organizations, and be unafraid to pursue necessary changes.

### Valued Colleagues and Leaders

Throughout her career, Cindy most appreciated working with trustworthy, team-oriented colleagues who were supportive, respectful, and open to different perspectives. These relationships were key to overcoming challenges and achieving success. As for leaders, those with vision and a willingness to take on new challenges were the most inspiring to Cindy.

### **Changes in Work Culture: Progress and Challenges**

During her time in Human Services, one of the most significant changes was the deinstitutionalization of people with developmental disabilities, mental health disorders, physical disabilities, and the elderly. This shift led to the development of community resources aimed at meeting individual needs. While much progress has been made, Cindy also noted that deinstitutionalization sometimes occurred without sufficient community resources to support those in need, making ongoing advocacy crucial.

#### **Looking Forward to Retirement**

Though no concrete plans are in place, Cindy looks forward to a new chapter filled with potential travel and relaxation. As she steps away from her long-standing role, she leaves with a deep appreciation for the relationships formed and the work accomplished.

#### **A Farewell Message**

In her parting words, Cindy expressed gratitude for the opportunity to work alongside so many dedicated individuals. "I would like to thank all Renville County employees for the work they do to make Renville County a better place for our citizens, especially our Human Services employees," she shared. She also extended thanks to the County Board of Commissioners for their support and advocacy over the years. "I am honored to have worked alongside so many others working to serve our community." ### YOU Can Make a Difference: Become a Restorative Justice Volunteer Today!



Restorative Justice is a fundamental change in approach when working to repair damages caused from crimes or wrongdoings within a community. This is not only a restorative philosophy but a way of life that emphasizes the need to restore

the relationships harmed in these situations.

What is a Circle? The Circle process is an intentional way of gathering and organizing effective group communication, building relationships, establishing accountability, problem solving, and healthy decision making. As a group, members work with the family or individual to determine what they can do to repair the harm they have caused by the circumstances that brought them to Circle. While in Circle, participants and volunteers discuss what is going well, any current concerns or worries, and potential next steps to restore the situation that brings them there.

This is a great way to get involved with people in your community or the one down the road. **The need for connection, support, and mentoring continues to grow as evidenced by the times we are in.** With that comes the reality that the number of youth and families in need of extra "It is so worth your time volunteering with Restorative Justice! ### **REAL ID is REALly Happening: Get Ready Now**



hile the federal

government gave us some breathing room, the new deadline for REAL ID will be here before you know it. Our Driver and Vehicle Services (DVS)

division is encouraging you to get ready now and beat the rush.

You've got until May 7, 2025, to get a REAL ID-compliant license. When the deadline hits, Minnesotans, and the rest of U.S. travelers, won't be able to use their standard driver's license to fly within the U.S. or visit some federal buildings. Instead, they will need to have a REAL ID-compliant license or a federal passport.

"Minnesotans need to know: REAL ID is going to happen. Get yours now and avoid the possibility of waiting in long lines before the May deadline," said DVS Director Pong Xiong. "You only need to apply for it once, and then renewing after that is easy."

The most important part of getting a REAL ID is having the right documents to prove your identity and residency.

You need one document proving your identity, date of birth, and legal U.S. presence, and two documents proving your Minnesota residence.

#### The documents must be original. DVS cannot accept:

- Photocopies
- Scanned images
- Faxed images
- Digital images on a cell phone or other electronic device
- Laminated documents

The name on those documents must match the name on the application. If you've changed your name for any reason, you'll need to bring proof of each name change from your birth to present day.

#### Examples of acceptable proof include certified copies of:

- Marriage certificate
- Divorce decree or dissolution of marriage
- Adoption decree
- Court-ordered name change

Shave off time at your office visit by pre-applying online at <u>drive.mn.gov</u>. The mobile-friendly web application includes the options to upload documents, so DVS can verify you have the right documents. It also lets you receive your REAL ID driver's license or ID card in 7-10 business days.



### Kandiyohi-Renville Community Health Board: Community Health Assessment Top 10 Health Priorities

andiyohi-Renville Community Health Board is excited to present our completed Community Health Assessment! Along with our completed Community Health Assessment (CHA), we've also selected a list of our top 10 health priorities for communities.

The CHA is a customary practice and core function of public health. This data compilation and trend analysis has been done over the past few years by a Kandiyohi-Renville performance management team, called KaRe to Achieve. After data analysis through the CHA and community input from our Community Call to Action



meetings, which were held in June of this year, a final selection of our top 10 issues was determined by the Kandiyohi-Renville CHB. These 10 priority community health concerns are submitted to the Minnesota Department of Health every five years.

### **OUR TOP 10 COMMUNITY HEALTH PRIORITIES ARE:**



**Access to Care** 

Access to care is difficult for general, mental, and dental health.



**Chronic Disease** 

Diseases such as high blood pressure, asthma and diabetes, which are chronic diseases that can last a lifetime.



**Adolescent Health** 

Sexual activity, bullying, and substance use among students.



**Food Security** The ability for people to find healthy and nutrient-dense foods.



Adverse Childhood Experiences (ACEs)

ACEs are negative experiences that shape lifelong health.



Housing Stability Stability and affordability of renting and owning.



**Aging Population** 

The state of our population and unique challenges that lie ahead due to general aging trends.



Mental Well-Being Effects of mental health difficulties are related to the majority of health issues.



**Childcare Access** 

Access to childcare from in-home providers to licensed centers.



**Substance Use** 

Consumption and purchasing of illicit and legal recreational substances by our general and student population.

Next steps: We will present the selected Top 10 Priorities to the Kandiyohi-Renville Community Leadership Team, who will help to further prioritize two to four health focuses. We will then continue to work with community partners to implement a Community Health Improvement Plan (CHIP), which helps guide programs, services, priorities, and partnerships in the next five years.

### Take Root in Soil Health

n the evening of August 28th, without a cloud in the sky, a small portion of Renville County soils were hit with an inch and a half of rain. The root cause of this torrential storm? The Renville County Soil and Water Conservation District (SWCD) at their answer plot in Wang Township! (See event photos to the right.)

These plots aren't your average seed, chemical, or nutrient test-based plots. Rather, the plot focuses on the soil health characteristics and economics of regenerative agriculture (think no-till and strip-till) and conventional agriculture.

With the help of partners\*, the SWCD simulated the rainstorm on a soil tray of long-term no-till, first-year no-till, and conventional tillage. Once the rain had passed, SWCD staff showed attendees of all ages the difference in soil texture, water infiltration, and runoff between all three management styles found at the plots.

You might be asking, "What tray of soil was the clear winner for my wallet and the environment?" As shown in the images to the right, the three buckets had varying amounts and colors of water. Both no-till treatments infiltrated most of the water into the buckets below and left a chocolate-cake like soil at the bottom of the tray. The conventional till treatment had a bone-dry bucket and powdery soil at the bottom of the soil tray, indicating that little to no water infiltrated the conventional soil.

No matter if it's a wet 2024 or dry 2023 growing season, soil health practices can help improve a soil's water infiltration and reduce soil erosion and the nutrients that go with it.





### Southwest Initiative Foundation (SWIF): Kathy Wehking Completes Six Years of Board Service with SWIF

athy Wehking of Hector is retiring from the Southwest Initiative Foundation (SWIF) Board of Directors following six years of service. Wehking started her term in 2018, drawing from her experience as an educator, community leader, and farmer. She served on the Foundation's Investment Committee, Development Committee, and Evaluation and Measurement Task Force.

"Kathy's knowledge of the ag sector, which is core to southwest Minnesota, has been of tremendous value as we think about our investments and our programs. She has an unwavering passion for rural, and she has championed the smallest of our small towns," said SWIF President Scott Marquardt. "We're thankful for Kathy's constant presence, curiosity, and willingness to take risks and learn alongside us."

The SWIF Board of Directors is a governing board that ensures the organization fulfills its mission of connecting people, investing in ideas, and building communities in southwest Minnesota. This volunteer board sets strategy, manages resources, and promotes the foundation's work.

Together with fellow board members, Wehking led the organization through the challenges of the COVID-19 pandemic. During her service, SWIF accelerated its investments to support access to quality, affordable child care; launched Welcoming Week and the Growing Local: Emerging Leaders Program; and leveraged connections and expertise to ensure relief and recovery funding flowed into the region's businesses and communities.

"My greatest joy as a board member has been the foundation's role in helping people take care of their communities and witnessing the incredible work they're doing," Wehking said. "I also enjoyed getting acquainted with many different places in our region. Sometimes it feels like we're undiscovered; it's been amazing to see all the things that can and are being done in southwest Minnesota."

In honor of her service, Wehking directed a \$600 grant from SWIF to support Little Stangs Learning Center in Buffalo Lake. As part of the Buffalo Lake-Hector-Stewart School District, the center provides early care and education for kids from birth to preschool.

Early care and education is a cause close to Wehking's heart as a retired educator. She also values the economic benefit child care provides in terms of supporting parents in the local workforce.

By investing in Little Stangs, we're not only supporting families but also fostering a thriving town and business environment," Wehking said. ### 2025 Solid Waste Special Assessment Dollars: How Are They Used?

he Redwood-Renville Regional Solid Waste Authority (RRRSWA) uses solid waste special assessment dollars to

provide services to manage and promote sustainable waste practices. (Your solid waste special assessment is located on your tax statement, listed as "Environmental Assessment.)

Here's how these dollars are used:

#### **Operating a Multi-County Recycling Program:**

Employ both County and contracted laborers to collect, load, and transport over 5,200 tons of recyclable materials annually, achieving a curbside recycling collection rate of more than 50% in Redwood and Renville Counties.

#### **Operating Facilities and Services:**

- Multi-County Transfer Facilities: Manage Municipal Solid Waste, Demolition, and Recycling Transfer Facilities, along with a separately located Demolition Landfill Facility. These facilities cater to both commercial and residential haulers, transporting nearly 16,000 tons of County-produced garbage and demolition materials annually to area landfills, in addition to management of 3,600 tons of on-site demolition waste each year.
- Household Hazardous Waste (HHW) Facilities: These facilities, located at the Renville County Demolition Landfill (Olivia) and the Redwood County HHW (Redwood Falls), allow residents to safely dispose of all types of household hazardous waste materials such as used oil, unusable flammable fuels, fluorescent/LED bulbs, paints, stains, home/agriculture chemicals, batteries, and more. These facilities also feature a "product exchange room" where residents can find, and reuse, good household items for free.

#### Additional Facility Services/Programs Include:

- Daily residential and commercial deposit locations for recycling, demolition debris, and garbage.
- Free document destruction for residents (small fee for businesses).
- Free scrap metal disposal at the RRRSWA and Renville County Landfill.
- Mattress recycling (collection and transportation services).
- Recycling of holiday lights and electrical cords at yearly/ seasonal drop sites.
- County sponsored bi-yearly tire recycling event for Renville County residents, and disposal throughout the year for Renville and Redwood County residents at the Renville County Demolition Landfill.
- Sale of backyard compost bins (while supplies last).
- Pop bottle recycling bins at gas stations countywide.
- Provide recycling trailers/bins for town celebrations, sporting events, and at County parks.
- Educational programs on recycling and solid waste management through various media channels for citizens, haulers, and contractors.
- Assist co-ops and citizens with empty pesticide container disposal information and options.

#### Support for City/Resident/Business Needs:

- Centralized contact for solid waste inquiries, disposal information, and hauler details.
- Manage and service twenty-six (26) rural/urban residential recycling sites across Redwood and Renville Counties.
- Inspections and coordination for residential and commercial demolition disposals.
- Assist with MPCA Permit by Rule Applications by providing paperwork/guidance/site inspections.
- Tax forfeited parcel review and inspections.
- Host collection events for electronic waste and appliances from April through October in Redwood and Renville Counties.

### Low-Interest Loan Programs for Well and Septic Improvements

Renville County administers lowinterest loan programs to assist property owners with upgrading or replacing a failing septic system and/or for repairing or replacing a damaged or contaminated well.



Loan terms are seven years for septics and 10 years for wells with an interest rate of 3%. This loan amount is added to property taxes as a special assessment with payment due twice a year along with property taxes.
