Renville County Housing Study Kick Off

Renville County HRA/EDA undertook a housing study this year, funded in part by a grant from the Southwest Initiative Foundation. contributions from our cities, and the HRA/EDA. We held our Housing Study "kick off" meeting with Matt Mullins with Maxfield Research on Thursday, February 27th at the RC Government Services Center. 7 of our 9 cities attended in person, and others called in. We video recorded it, and emailed a link to that and info request forms for the consultant to all the cities.

Human Resources & Manufacturing Association

Renville County HRA/EDA partnered with Redwood County Economic Development, Central MN Jobs & Training Services, the SW MN Private Industry Council & area Chambers to start a multi county Human Resources Professionals group to allow for training opportunities and networking for our HR professionals at private businesses, nonprofits and government organizations. We had planned to hold these quarterly events starting April 16th but due to the pandemic this program has been put on hold. We are hopeful they can begin in 2021.

<u>ST Sports – Olivia</u>

Renville County EDA's loan to ST Sports in Olivia, which was approved by the HRA/EDA Board at their February Board Meeting, was closed on March 18th. This loan was in conjunction with F&M Bank Minnesota – Olivia, the City of Olivia EDA and the Mid-Minnesota Regional Development Commission.

Emergency Business Bridge Loan Program

In March, the Renville County HRA/EDA created the "Emergency Business Bridge Loan Program" with \$50,000 in reserve funds to assist businesses that were impacted by the fight against COVID-19. The program was designed to provide up to \$2,500 in bridge financing until new programs from the SBA were rolled out. Most businesses receiving these loans were ordered closed or to have modified business practices by the Governor's Executive Orders 20-04 and 20-08 – pertaining to bars, restaurants and personal services.

Loans were marketed to our email distribution lists of Cities, Lenders, Elected Officials & Boards, and via social media and press releases, etc. In all, 21 Renville County Businesses received loans. Locations of loan recipients are as follows: Bird Island – 3, Danube – 1, Fairfax-1, Franklin-1, Hector-3, Olivia-9, and Renville-3.

TC&W Railroad Event

Staff were invited to an event hosted by the Twin Cities and Western Railroad / MN Prairie Line on March 11th. It was a great networking event, and we started discussions on grant opportunities with the Minnesota Valley Regional Rail Authority, staff from Congressman Peterson's office and others on grant opportunities from the Federal EDA. Childcare Appreciation






Small Business RLF Loan

Renville County Housing Study

The Renville County Housing Study was delivered to us on September 24th and posted on our website: www.renville.com A kick-off event was held on Thursday, September 24th at 3:30 PM with about 30 people attending. Due to the pandemic, this event was held in an online format. A press release was sent out to the news media and invitations were sent to HRA/EDA Board Members, County Commissioners, cities, townships, elected officials, lenders, developer, builders, property management companies, lumber vards, real estate agents, and others to attend. Land Sales

Renville County HRA/EDA closed on the sale of approximately 2.59 acres of land located near Olivia Hospital to the City of Olivia's EDA on November 12th. Purchaser Mr. Vannelli terminated our purchase and development agreement with him prior to the sale, and the Olivia EDA is now working on their own agreement with him.

The second land sale project is for the sale of approximately 1 acre of land near Olivia Hospital from Renville County to the Olivia Ambulance Service – this would be a pass-through for the Renville County HRA/EDA. This transaction has been approved by the Renville County Board of Commissioners and the Renville County HRA/EDA Board. We anticipate having a closing on this transaction soon.

CARES Act Grants Completed

Renville County completed the awarding of grants through CARES Act funds to 111 Renville County businesses and nonprofits that total \$509,928.38.

These grant funds were sourced from the Federal CARES Act dollars provided to Renville County, and subsequently allocated by the Renville County Board of Commissioners to the HRA/EDA to provide these grants. The maximum grant to businesses was \$7,500, and \$5,000 for nonprofits. Grants awarded were based on eligible expenses incurred by applicants from March – August, 2020. A press release has been sent out announcing these grants.
