The nine-member Parks and Trails Committee meets quarterly. One member is appointed by the Renville County Board of Commissioners from each of the five commissioner voting districts with four members selected at-large, two of which are youth members. Members serve three-year terms with a term limit of nine consecutive years. Each Parks and Trails Committee Member is paid a per diem of \$65 per meeting plus compensation for mileage to and from meetings.

The Parks and Trails Committee has the following duties and responsibilities.

- Study, report, and make recommendations on amendments to the Park Ordinance and the Parks and Trails Plain prior to adoption of an amendment by the Renville County Board of Commissioners.
- 2. Conduct public hearings, review all information, and prepare a report and recommendation to the County Board on park land acquisition and development.
- 3. Act as an advisory committee to the County Board reviewing all recreation, leisure, and park-related issues including park planning, operation, maintenance, protection, and improvement and trail related issues including trail planning, development, construction, operation and maintenance, and funding sources.
- 4. Study and recommend appropriate fees for park permits and trail system user fees.
- 5. Such other duties as the Renville County Board of Commissioners may recommend.

Parks Department Staff



The Renville County Parks Department maintains the seven county parks and provides grounds keeping at several of the Public Works buildings, the Government Services Center complex, Renville County Fairgrounds, and the Birch Coulee Battle Field grounds. The Department has two full-time employees. A Park Manager, whose primary duties are performed within the office, but who also provides direction and assistance in the field when needed, and the Lead Maintenance Worker whose duties are performed in the field. There are also four seasonal park maintenance

workers that assist the Lead Maintenance worker, generally between the months of May and August. The Parks Department also received assistance from the Highway Department when help is needed.

The primary focus of the maintenance crew is to maintain the current conditions of the parks, which included mowing common areas, cleaning of the shelters, restrooms, horse bunkers, and campsites and other routine maintenance.

While maintaining the parks a few other things parks staff accomplished were:

- Assisted with camping reservations.
- Trail work and repairs.
- Cut, split and supplied wood at parks for campers.
- Re-mulched plants and flower beds in all of the parks.
- Attended the Willmar Outdoor Expo.
- Attended Farm Fest
- Attended the Renville County Fair.
- Attended Upper Sioux Agency State Park community meetings.
- Held the second annual Parks Outdoor Education Day at Birch Coulee.
- Fixed and stained picnic tables and benches.
- Cut trees along park roads and trails.
- Mow and maintained Birch Coulee Battlefield, County Highway Shops, Fairgrounds and the Government Services Campus.

Contracted Work

- · Groomed winter trails at Beaver Falls and Skalbekken.
- Vicksburg Shelter reroofed and a ceiling installed
- Lake Allie Reroofed due to storm damage.

The Renville County Parks Department tracked camping usage within the park system via camping permits. Camping fees for rustic camping are the same in all parks. Campsites with electric and water have different rates.

with attendees (Selfie station was also used at the Spring Outdoor Expo and Farm Fest). Email addresses were collected from registrants and placed in database for marketing Renville County Parks and tourism.



Southern MN Tourism Association (SMTA):

Represented Renville County in the Southern MN Tourism Association regular, executive committee and marketing committee meetings. Placed a print ad in the STMA Tourism Guide. 300,000 copies will be printed and distributed throughout Minnesota, along with an electronic version.



Outdoor Education Day: Hosted the second annual Renville County Parks Outdoor Education Day. 166 students from Prairie Lutheran, GFW, BLHS, and RCW school districts attended the

event, which was held at Birch Coulee County Park. Partners included the EDA, Extension Office, Sheriff's Office, Environmental Services Office, Public Works, GIS, SWCD, Master Gardeners, Historical Society, and RAPAD.
