budgets and decisions. Being elected as a new Commissioner can carry both of these issues. It's a tough balance that Commissioner Greg Snow now finds himself in the thick of.

"Moving to Olivia really changed my perspective on life in general. Being part of a small community was really eye opening and refreshing from the big city life that I had known for 25 years of my life. Getting involved felt like the norm rather than the exception, and I really wanted to get involved," Snow told of his decision to run for office in District 4.

### **GREG SNOW**

### **New District 4 Commissioner**

Being a new employee, it can be tough to adjust while figuring out your job. Being a new manager can be more difficult because you have to manage people, ns. Being elected The 4th Commission District covers the cities of Olivia and Danube, along with the Township of Troy at large. While it is the smallest district in geographic area, by covering Olivia, Commissioner Snow has the tall task of representing the County Seat and Renville County's largest community, by population. The district had been represented by John Stahl for four consecutive terms and taking over for a commissioner sitting on the County Board for 16 years is not lost on Greg.

"I have never heard one disparaging word about John. He served our community well and was very involved," commented Snow. When asked if he feels he has big shoes to fill, Snow responded. "Yes - big shoes is the correct term." Reflecting on his election last November, he remembers one particular thought, "I kept thinking nothing really changes if we don't win so it's okay and then when we won, everything changed."

#### GREG SNOW New District 4 Commissioner

Born in the Arrowhead region of Minnesota, in Two Harbors, Commissioner Snow grew up in Silver Bay and moved just north of the Twin Cities for high school and college in St. Francis. Graduating from Pillsbury Baptist Bible College with a History major and Sport Coaching minor, Greg initially moved to Olivia to be the Head Golf Professional of the Olivia Golf Club in 2011. He is also a coach at BOLD and RCW High Schools. With so much community involvement Snow shared, *"I guess you could say it just happened. The ability to say 'NO' has always been a challenge for me, and once I get involved I fall in love with the project or the people I am involved with."* 

His hobbies, as you might expect, include golf (shocker!) and attending his kids' sporting events. The new commissioner also opened up about an unusual habit of his. *"I cry at the dumbest things,"* Snow commented. *"For example, the movie "The Mighty Ducks" when one player gave another player his jersey. I lose it every time!" Being Minnesota is the State of Hockey, Greg is probably not alone with his weakness for the "The Mighty Ducks."* 

Walking into the County Board, or any of his other duties, Commissioner Snow draws his motivation from a simple source - a drive to make people smile. As for what he feels he brings to the table as a Commissioner, "I hope to bring zest and positive energy and maybe a new perspective on things. I am still heavily in the learning process, and it's been great watching these four interact. The questions that they ask, and the insight they have, will hopefully help me grow as a commissioner. And for those who know me, I try to bring some humor as well."

Snow gives a lot of credit to the other four commissioners for helping him through the learning curve of this new role and accepting him into the fold that has made for a smooth transition. He is standing by his campaign statement by not having an agenda and being part of the decisions that are going well for the county is what he is looking forward to. *"I want to help make the best decisions possible for the citizens of Renville County. I did not run trying to change the world."* Snow stated.

As the interview wraps up, how does Commissioner Snow feel about working for his local government? "It's as great as I thought it would be. Overwhelming at times, because we new commissioners are drinking from a firehose at this point in our careers! Overall it's been great!" Snow concluded.

### LISA NEUTGENS Human Resource Coordinator



Sometimes, when a new position is being filled, there can be a screeching halt to 'normal business' until the new person can catch up. However, when Lisa Neutgens took over the positon of Human Resource Coordinator, she found she was able to hit the ground running.

was start to gain the knowledge the previous coordinator had after 14 years of working here. I have some big shoes to fill," Neutgens commented.

Neutgens' job deals mainly with assisting county employees with benefits, communications and interviewing potential candidates for open positions. Each day, Lisa walks into the office ready for the diversity and flexibility that the job brings her. Positions can open at the county after 15, 20 or 30+ years under the same person. Lisa is ready to find the right people to fill these jobs for the county.

Not unfamiliar with working in the county offices, Lisa had previously worked for the U of M Renville County Extension office. Originally from Sacred Heart, Neutgens got her degree in Agriculture Education at the U of M and her Master's in Education at the U of M – Duluth. She made the jump to human resources to spend more time at home with her two daughters, ages 5 and 2. "Does chasing my kids around count as a hobby?" she asked. When she does get a free moment, she is most likely to pick up a good book or start planning her next travel adventure. "I think that throughout all my positions the service part, the helping people, has been what I am most proud of," Neutgens commented on her best achievement to date.

While she may be behind the scenes, that doesn't mean the public won't hear from her. *"I want to get the word out about the large variety of positions here at the county, each with different education level requirements. Anyone can apply to be part of Renville County," she explained.* 

It is especially important to Lisa that she gives credit to her coworkers for making her job so rewarding. Solving even the smallest problems is her favorite part of the job. When she is able to help an employee, it makes it a great day for her. #### Complete Count Committees



The 2020 Census is very important to our community for funding allocation and elected representation. On February 12, 2019 the Renville County Board authorized the creation of a 2020 Complete Count Committee (CCC) and Partnership. In March, a Census representative was on-site to provide an overview of the 2020 Census process to fifteen interested members of the community. We are currently in the process of scheduling training for those interested in being part of the Complete Count Committee; the committee's primary goals are to create awareness across the community to ensure that everyone is counted.

#### Some of the specific tasks that may be completed by the CCC include:

- Holding CCC kickoff meetings with media briefings.
- Participating in Census rallies or parades.
- Coordinating Census unity youth forums.
- Hosting interfaith breakfasts and weekend events.
- Encouraging the use of Statistics in Schools classroom resources.
- Incorporating census information in newsletters, social media posts, podcasts, mailings, and websites.
- Helping recruit census workers when jobs become available.

### Got GIS ? Renville County Does!

Did you know that you have access to public GIS data? Well you can't say 'no' any longer. Geographic Information Science (GIS) is the practice of putting information and data into spatial form. This creates a representation of the real world on a map with information behind such as; an address point with a mailing address, a street with its name or a parcel with a parcel number.

Renville County's GIS Specialist, Alex Lange, is responsible for maintaining this GIS data, or data layers, and assisting county offices making maps for specific uses or public release.

By visiting the Renville County website at <u>www.renvillecountymn.com</u>, clicking on 'GIS/ Maps' and then the GIS Homepage picture link you will reach the GIS Portal. You will see several custom built web maps, or apps, from the county and the county's GIS vendor, Pro West, including:

- Road Closures Map: view current county road closures
- Tax Parcel Viewer: view parcel layers
- **Historic Imagery Viewer**: view imagery from 1927 and 2014 side by side
- Ditch Mapping Application: view county ditch and tile lines

Most of the county's GIS data is on the 'LINK' and '**Mobile LINK**' apps. These hold data such as roads, parcels, lakes/rivers, water access, golf courses, address points and county aerial imagery from 2009, 2014 and 2018.

All data (except aerial imagery) can be downloaded on the 'Open Data' site, located on the portal. Renville County is continually updating current data and looking to get more data out there for public use, so check back to see what new data, apps, and features the county is working to bring you.

### **Minnesota Licenses and ID Cards**



innesota has a few identification options for residents to choose from.

- Standard driver's license or ID card.
- Enhanced driver's license or ID card (EDL/EID).

• REAL ID-compliant driver's license or ID card.

Determining which type of license or ID card works best depends on what a person needs to use the card for.

#### Standard Driver's License or ID Card

A standard license or ID card can be used for federal purposes, including boarding domestic flights, until Oct. 1, 2020.

- including boarding domestic flights, until Oct. 1, 2020.
- After October 2020, these won't be acceptable forms of identification for domestic air travel or federal use.
- Valid for identification purposes.
- Valid for lawful driving privileges.

#### **Enhanced Driver's License or ID Card**

• Can be used for domestic air travel and to access federal facilities now and will continue to be acceptable forms of identification for federal purposes even after October 2020.

- Can be used as U.S. border crossing documents.
- Only issued to U.S. citizens.
- Valid for identification purposes.
- Valid for lawful driving privileges.

#### **REAL ID Compliant Driver's Licenses or ID Card**

• REAL ID driver's licenses or ID cards can be used for domestic air travel and to access federal facilities such as military bases and nuclear power plants.

- Issued to both U.S. and non-U.S. citizens.
- Cannot be used as border crossing documents.
- Valid for identification purposes.
- Valid for lawful driving privileges.

#### What is REAL ID?

Passed by Congress in 2005, the REAL ID Act establishes minimum security standards for state-issued driver's licenses and ID cards. The Act refers to federal anti-terrorism laws and regulations that control access to the following:

• Federally regulated commercial aircraft.

• Federal facilities requiring identification to enter, such as military bases or nuclear power facilities.

The Act prohibits federal agencies like the Transportation Security Administration (TSA) from accepting cards for official purposes from states that do not meet minimum security standards.

### **Renville County Restorative Justice**



Restorative Justice is a fundamental change in approach when working to repair the damages caused from crimes or wrongdoings within a community. This philosophy sees crimes as a violation of both the law and the relationships that were impacted by the incident.

"Through the Restorative Justice

program, we seek to hold people accountable in rebuilding these relationships and repairing the harm that was caused by their actions," shared Andrew Peltz, Restorative Justice Coordinator. "There are many processes that are considered to be restorative models, including conferencing, victim offender dialogue, family group conferencing, and circle. Circle will be the restorative process utilized in Renville County." Continued Peltz.

A Circle is a structured process based upon Native American and Aboriginal traditions used for organizing effective group communication, building relationships, accountability, problem solving, and healthy decision making. People come together and meet in a literal circle where everyone is given an opportunity to share their perspective and work together in finding solutions.

As a group, the circle works with the family or individual to determine what they can do to repair the harm they have caused by the offenses or circumstances that brought

them to circle. This can include, but is not limited to things such as community service, restitution, apology letters and meeting in circle with the victim to have a restorative dialog regarding what happened. Generally, circle will be held every other week and last about two hours.



Relationships are crucial to the program's success on multiple levels. This first starts with creating a positive working relationship with different departments such as; Human Services, Probation, County Attorney's Office, local Law Enforcement, and area schools. However, without support and relationships created within the community this program would not be possible. Furthermore, establishing relationships within the groups prior to addressing the issues and developing a plan will be vital in achieving success for all involved.

Andrew Peltz has accepted the position of Restorative Justice Coordinator. He is tasked with getting the program up and running in Renville County. Peltz graduated from Southwest Minnesota State University in Marshall with a Bachelor of Arts degree in Sociology, a Bachelor of Science degree in Justice Administration and a minor in Psychology.

### Update on the Minnesota Buffer Law in Renville County

The Minnesota buffer law requires vegetative buffers along waterways to protect water quality. Public ditches require a 16.5 foot buffer and public waters require a 50 foot buffer. Renville County landowners have made significant progress in buffer compliance, overcoming unfavorable weather and other difficulties.

#### **Renville County Cost-Share**

To assist landowners with the installation of buffers, the Renville County Soil and Water Conservation District (SWCD) has Cost-Share funds available to install vegetative buffers to meet the Minnesota buffer law requirements. Seed mixes must be pre-approved by the SWCD before purchase to qualify. Cost-share rates are \$225 per acre for introduced mixes and \$300 per acre for native mixes.

### SETH SPARKS Drainage Systems Manager

Redetermination, buffer, maintenance and open ditch to tile line improvements. That's the world that new Ditch Systems Manager, Seth Sparks has dived into. With the retirement of Larry Zupke, Sparks has taken over the Ditch Department of Public Works. Drainage Systems Manager is not the typical county position, as a lot of the work comes down to requests from the public to set the work that needs to be done. But, according to

Seth, helping the public by fulfilling those requests is what motivates him when he gets into the office. The satisfaction of completing a project is what he finds most rewarding when he leaves.

Sparks, originally from *"all the way"* in Clara City, got his degree in Environmental Sciences from South Dakota State (Go Jackrabbits!). He made his way to Renville County after working for his uncle's construction company, and a CO-OP, where he obtained experience in the agricultural field.

In December 2015, Sparks started working for Renville County. He credits his prior employment for getting him to where he is now. *"The job was a good mix of construction and drainage work that I had done at both my previous positions."* he explained. But, when asked what his best accomplishment was, he turned to the personal side of his life and pointed to his wife and his 1 year old son. The family currently resides in Belview, where he and his family enjoy the typical outdoor activities. Going Elk hunting in Montana is a particular favorite of his.

Getting back to the job, Seth points to washouts, tile line and explaining the process for improvements as typical requests he gets from the public when they stop by the county offices. *"I think that sometimes people don't know a lot about the online resources we have out there. Between GIS web maps and paper scanned maps, there is a lot*  of information available for the public." Seth responded when asked what he thinks the public might not know about. Wrapping up the interview, Seth also wanted to give credit to the great crew that works in the Public Works department. His coworkers make it a great job to come into every day.

#### **Drainage Department Organizational Changes**

In addition to Sparks' acceptance of the Drainage Systems Manager position, there have been many other drainagerelated organizational changes that have taken place over the last six months:

• The duties of agricultural inspection, previously the responsibility of the Drainage Department, are now provided by contract with the Soil and Water Conservation District (SWCD).

• Diane Mitchell, Environmental Services Assistant Director, worked with the MN Department of Agriculture so Renville County can utilize AgBMP funds for ditch buffer strip finance (the first Minnesota County to do so!).

• Josh VanderVoort was hired into a newly added Deputy Auditor-Treasurer position to focus on drainage system finances and drainage authority secretary duties.

• Larry Zupke came back on a temporary, part-time basis to assist with the 60 drainage system redeterminations that are currently underway.

• Alex Lange, GIS Specialist, has been assisting the Drainage Department with updating their GIS map. This is increasing the accuracy of the interactive map and laying a foundation for additional layers that will be added this year.

#### ATTENTION: Renville County Property Owners

he Assessor's Office will be continuing its annual property

inspections this summer. The Assessor's Office maintains records on the physical characteristics of each property in the county and is required by state law to physically review each property to record any changes.

Renville County's policy is to view each parcel every year. This review ensures the accuracy of data and assists in estimating fair and equitable values for property tax purposes.

Appraisers will be out verifying classification of properties, homestead status, and characteristics and condition of houses and buildings. The properties that are viewed this year are for 2020 values for taxes payable in 2021. Property values are determined from the property information gathered and analyzing sales data.

There are currently four appraisers in the Renville County Assessor's Office and two local appraisers that cover 27 townships and 10 towns. Appraisers will be out viewing beginning in May and will continue viewing properties through winter. Business cards are left at the property letting homeowners know an appraiser stopped by.

### Low Interest Loan Programs for Well and Septic Improvements

enville County administers several low-interest loan programs to assist property owners with upgrading or replacing a failing septic system or for repairing or replacing a damaged, noncompliant or contaminated well.

Loan terms are for 10 years with an interest rate of 3%. This loan amount is added to property taxes as a special assessment with payment due twice a year along with property taxes. Loans for new building sites or already completed repairs or installations are not eligible.

### Introducing eWIC

Renville County Public Health Services offers WIC to eligible pregnant and new mothers, babies, and children up to age 5. WIC is a USDA nutrition and breastfeeding program that provides nutrition education, breastfeeding support, nutritious foods, and referrals to health and other social services. Approved WIC foods include milk, cheese, eggs, juice, fruits and vegetables, cereal, whole grain breads and pasta, beans, peanut butter, and infant food.

Approximately 400 women and children are served each month in Renville County. WIC is provided three days a week at Renville County Government Center. The clinic is staffed by nurses and a WIC clerk.

**New in April 2019, is eWIC.** In the past, each WIC participant received separate paper vouchers which listed all the prescribed food they could purchase. The eWIC system will provide household benefits on one card. Participants no longer have to buy all of the WIC foods at one time. In some stores, it will not be necessary to separate WIC foods from other groceries. Food benefits on the card will expire after 30 days and unused items do not roll over.

WIC participants create a specific PIN to allow them to check their account for the balance of remaining foods, use Food Finder features, find WIC stores, and view shopping tips.

### **Renville County Students Attend County Government Day**

Students from BOLD, BLH and RCW school districts had the opportunity to attend Renville County's "County Government Day" on April 9th. The day began with registration and breakfast in the Government Services Center. The students recited the Pledge of Allegiance and then toured the large courtroom and spoke with the Court Services Department.

Next, the students split into four groups and received a virtual tour of the Renville County Jail, met with the Public Health Department, and toured the Sheriff's Office. Each group also participated in a questionnaire scavenger hunt that brought them to a mix of departments within the county. The questionnaire was designed to assist students in learning what each county department is responsible for.

Once tours were complete, the students had an opportunity to meet with the Renville County Commissioners to present issues and ask questions.

After speaking with the Commissioners, students headed downstairs for lunch, and then wrapped up the day with a tour of the Renville County Hospital.



County Government Day is hosted by the Renville County Veterans Association. Local Veterans volunteer to help coordinate, assemble information packets for students and assist with lining up breakfast and lunch. Veterans also participate during the actual event as volunteers touring with the students.






