The public hearing will be conducted as both in-person, at the location listed above, and via alternative means (teleconference or video-conference) from remote locations. Members of the Drainage Authority Board of Commissioners may be participating remotely using interactive technology.

The Petition for Outlet requests the express authority from the Renville County Board of Commissioners acting as the drainage authority for Judicial Ditch 28A to use the Judicial Ditch 28A system as an outlet for the following described real property, 157 acres in section 8-115N-31W Preston Lake Twp (see attached map). Once available, a copy of the viewers’ report recommending benefits for the petitioned acres and an outlet fee will also be available for inspection at the office of Seth Sparks. At the public hearing, the Drainage Authority will accept public comment regarding the petition and viewers’ report. Written comments will be accepted by mail or email received by the Renville County Drainage System’s Manager, Seth Sparks, up to 8:30 a.m. on April 7, 2026. Any comments received by mail or email prior to the public hearing will be read into the record at the April 7, 2026 meeting.
