The Petition requests the removal of 129 acres found in section 8-115N-31W Preston Lake Twp (see attached map) from Judicial Ditch 15. The Petition states that the Petitioner is concurrently petitioning the Renville County Board of Commissioners, drainage authority for Judicial Ditch 28A, for express authority to use JD 28A as an outlet for drainage and asks that this Petition be granted contingent on the Judicial Ditch 28A Petition also being granted.
