PUBLIC HEARING NOTICE

PLEASE TAKE NOTICE, that the Board of Commissioners of Kandiyohi Meeker Renville Joint County Drainage Authority, acting as the public drainage authority under Minnesota Statutes, chapter 103E (“Drainage Authority”) for Kandiyohi Meeker Renville Judicial Ditch 1 (“JD 1”) pursuant to Minnesota Statutes, section 103E.806, shall hold a public hearing on the petition of Huisman Properties LLC, Johnny Hanson, Jerry Hanson, David Nelson, Larry Johnson, and Arlene Preslicka (“Petition”) requesting to abandon a part of Kandiyohi Meeker Renville Joint Ditch 1 Lateral B Branch 1 (“JD 1 Lat B Br 1”). The Petition seeks to partially abandon a portion of JD 1 Lat B Br 1 from the south side of 105th Avenue SE, north to the beginning of JD 1 Lat B Br 1.

The public hearing on the Petition shall be held on April 7, 2026, at 1:00 p.m., or shortly thereafter as the agenda allows, in the Commissioners Board Room of the Health and Human Services Building, 2200 23rd Street NE, Willmar, Minnesota. Members of the Joint County Drainage Authority Board of Commissioners may participate by interactive technology from remote locations.
